Dear Sir/ Madam,

On receipt of representations of several stake-holders it has been decided that no pepal-action should be taken against producers/traders of such products who are selling standard and authorized pack sizes but only the wrapper being used by them contains wrongly the words: "Non-Standard Packs". This may be done till 31st May 2013 to enable the industry to exhaust their inventories/ stock of old, unused wrapping and packing material as standard quantity.

2. The manufacturers are being requested to exhaust the incorrect wrappers first by supplying to institutional and industrial customers.

3. In respect of the remaining products, other than bottles, the words 'Non' may be blocked with stickers and supply may be arranged in standard quantity.

In respect of the bottles, the quantity of which should be relatively less after supply to industrial and institutional customers and where it may be difficult to block the words, may be allowed to use the existing unexhausted wrappers and may be sold to standard quantity.

5. Whenever necessary a declaration/affidavit can be taken from the producers that they are using only the existing inventory of printed packing material/bottles.



Sir,

The undersigned is directed to refer to the above cited subject and to state that it has come to the notice that some of the retailers are selling the packaged commodities in loose form after tearing the package.

- 2. Please be informed that under Rule 4 of the Legal Metrology (Packaged Commodities) Rules, 2011, provision is made for not selling pre-packaged commodity, if a label is affixed on it, having such declarations as are required to be made under these rules, as follows:
- On and from the commencement of these rules, no person shall pre-pack or cause or permit to be pre-packed any commodity for sale, distribution or delivery unless the package in which the commodity, a label is securely affixed and such declarations as are required to be made under these rules."
- 3. Further, it is to inform that under Rule 6 of the Legal Metrology (Packaged Commodities) Rules, 2011 the following mandatory declarations are required on every package-
- "(i) Name & Address of the manufactures/packer/importer
- (ii) Name of the commodity
- (iii) The net quantity in terms of the standard unit or weight are measured
- (iv) Month and year in which commodity manufactured or pre-packed or imported shall be mentioned
- (v) Retail sale price of the package
- (vi) Consumer care details"





- 4. Therefore, it is advised to direct the field officers to ensure that no packaged commodity including cigarette, cigar, bidi etc. is to be sold in loose form after tearing the package.
- 5. This issues with the approval of the Competent Authority.

Subject: Sale of medical devices without mandatory declarations- compliance of Legal Metrology Act and Rules made there under- reg.

Sir,

Please be informed that all medical devices are covered under the Legal Metrology Act 2009 and Legal Metrology (Packaged Commodities) Rules, 2011 and therefore required to provide all mandatory declarations on their packages viz.:

- (i) Name and address of the manufacturer/ packer/ importer;
- (ii) Common or generic name of the commodity contained in the package;
- (iii) Net quantity, in terms of standard unit of weight or measure or in number;
- (iv) Month and year of manufacture/ pack/ import;
- (v) Retail sale price in the form of Maximum Retail Price (MRP) Rs..... Inclusive of all taxes;
- (vi) Consumer care details
- 2. It has come to the notice that in some cases the mandatory declarations are not printed on the packages of the medical devices, which is violation of provisions of Act and Rules.
- 3. Therefore, it is requested to issue suitable directions to your Legal Metrology Officers for compliance of mandatory declarations on the packages of medical devices.
- 4. It is also requested to inform this office the action taken in this regard.

Sir,

The undersigned is directed to refer to the above cited subject and to state that it has come to the notice of this Department that in the same city/ District/ State some manufacturers and importers are selling pre-packaged commodities at different (dual) MRPs. It is observed that at Hotels, Restaurants, dhabas, Airports, Railway Stations and at many other public outlets it is done at large, which is violation of Legal Metrology (Packaged Commodities) Rules, 2011 and Legal Metrology Act, 2009.

- 2. In this connection this Department has circulated NCDRC order 1.2.2016 to the Controller of Legal Metrology of all States and UTs, wherein it was stated that "there cannot be two MRPs, except in accordance with the law".
- 3. Further, it is to inform that there was a Stay order of Delhi High Court for not taking any action against Hotels and Restaurants for selling packaged commodities at a price higher than MRP, which has been vacated and action may be taken against Hotels and Restaurants for charging more than MRP.
- 4. Therefore, it is requested to take immediate necessary action to protect the interest of consumers and to comply the provisions of Law.
- 5. The action taken in this regard may kindly be informed.

Sir,

In continuation of this office letter No. WM-10(62)/2016 dated 24.10.2016 and 2.12.2016 (copy enclosed) the undersigned is directed to refer to the above cited subject and to state that it has come to the notice of this Department that in the same city/ District/ State some manufacturers and importers are selling same pre-packaged commodities at different (dual) MRPs. Department has already circulated a copy of the National Consumer Disputes Redressal Commission's order dated 1.2.2016 to all States and UTs, wherein it was stated that "there cannot be two MRPs, except in accordance with the law".

- 2. It is advised to check, along with net content checking, at the manufacturing/ importing points that the same pre-packaged commodities are not packed/ released at different MRPs.
- 3. It is also advised to ensure that at Hotels, Restaurants, dhabas, Airports, Railway Stations, Malls and at many other public outlets the packaged commodities do not have dual MRPs and are not sold at a price higher than MRP, which is a violation of Legal Metrology (Packaged Commodities) Rules, 2011 and Legal Metrology Act, 2009.
- 4. The assistance of the Director (Legal Metrology) and Deputy Directors, Regional Reference Standards Laboratories may be taken wherever required for net content checking/inspections etc.
- 5. Therefore, it is requested to take immediate necessary action to protect the interest of consumers.

In exercise of the powers conferred by rule 33(1) of the Legal Metrology commodities) Rules, 2011, in respect of Single Brand retail trading entities the legal Government hereby relaxes the manner of declaration of the retail sale price for a period of one year from the date of this order, in the following manner and subject to the conditions mentioned thereunder.

- through exclusive retail stores by such Foreign Single Brand retail trading entities which would be applicable to (a) the products sold under a single brand retail stores by such Foreign Single Brand retail trading entities which fulfill the single brand retailing, namely the products branded during manufacturing and sold under a single brand through exclusive retail stores;
- (2) Retail sale price of the products displayed for sale on the racks in a store will be made through the labels affixed to the racks. Additionally, the pre-packaged commodities for sale shall contain bar codes on the principal display panel, which will show the retail when read using price scanners available across the store. The above entities that Price Scanners are in working condition at all times.
- a pre-packaged commodity is imported into the country or moderated/packaged within the country, the retail sale price of the same shall not be upwards during product lifecycle. For ensuring compliance to the aforement and consistency of pricing, the single brand retail entity shall on its own cost to:
 - a) Make the retail sale price information available on its website;
 - b) Print a catalogue of retail sale prices and make the copies of the same available to the Director of Legal Metrology and Controller of Legal Metrology under whose purisdiction the retail stores are located;
 - c) Deposit the retail sale price information with a third party repository. The pository shall provide information regarding the retail sale price to consumers

wish to cross verify the same, through a consumer friendly web based App and a call centre with toll free number. Information regarding the aforementioned facility shall be prominently displayed on the website of the single brand retail trading entity and near the billing counter of the store;

- 4) Except for the above mentioned relaxation, the provisions of the Legal Metrology Act, 2009 and rules made there under and other Laws in force shall be applicable to the single brand retail trading entities in the same manner as they apply to others;
- The above mentioned relaxation may be reviewed or withdrawn at any point of time by the central government in case of non-compliance of the conditions by the single total the central government to initiation of action under the Legal Metrology Act and the rules:
- 6) From on this order do not preclude declaration of the MRP on pre-packaged (Ornmodities) by means permitted under the Legal Metrology (Packaged Commodities) Rules, the Single Brand Retail Entity chooses to do so.

7) The printing can start availing the relaxation until it satisfies to the Department of Consumer Affairs, Government of India that it fulfils the conditions mentioned above and receives conditions of the central government.



The undersigned is directed to refer to the above-mentioned subject and to state that representations have been received from Industries Associations that readymade garment industries are being subjected to prosecution action for minor inadvertent mistakes on packages, which is adversely affecting their business without any commensurate benefit to the consumers.

- 2. On the representation of the Industries Associations, it is advised that:
 - i. The primary objective of the Packaged Commodities Rules 2011 is to provide quantity assurance to the consumers. Therefore, at the time of undertaking enforcement action this should be kept in mind.
- ii. Rule 33 provides for relaxation under certain circumstances and whenever some minor inadvertent errors take place in the packaging, the manufacturers can approach the Central Government for relaxation which will be examined and dealt with appropriately on a case to case basis.
- iii. The industry associations have also represented to this Department that in some cases articles which are to be sold piece-wise but a number of pieces packaged together for the sake of convenience in handling and to save them from deterioration, are also being treated as pre-packaged commodities by the field level officers. In this regard, it is to clarify that the definition of 'Package' as in the now repealed standards of Weights and Measures Act, 1976 and the pre-packaged commodities as in the Legal Metrology Act, 2009 are different and field legal metrology officers are expected to understand the difference.
- iv. There is also a need for education of the manufacturers and product sellers and interaction with them so that there will be correct understanding of law, and its implementations in the right spirit.
- 3. This issues with the approval of the Competent Authority.

The undersigned is directed to refer to the above mentioned subject and to state that Section 24(1) of the Legal Metrology Act, 2009 states that:

"24. Verification and stamping of weight or measure. (1) Every person having any weight or measure in his possession, custody or control in circumstances indicating that such weight or measure is being, or is intended or is likely to be, used by him in any transaction or for protection, shall, before putting such weight or measure into such use, have such weight or measure verified at such place and during such hours as the Controller may, by general or special order, specify in this behalf, on payment of such fees as may be prescribed."

Where the words transaction and protection are defined under Section 2(u) and Sec n 2(k) of the said Act as follows:

- "2 (u) "transaction" means,-
- (i) any contract, whether for sale, purchase, exchange or any other purpose, or
- (ii) any assessment of royalty, 'toll, duty or other dues, or
- (iii) the assessment of any work done, wages due or services rendered;
- 2 (k) "protection" means the utilization of reading obtained from any weight or measure, for the purpose of determining any step which is required to be taken to safeguard the well-being of any human being or animal, or to protect any commodity, vegetation or thing, whether individually or collectively;"
- 2. 6 Therefore the weights and measures used for any transaction and for protection shall by the verified and stamped. The enforcement officers may be directed to verify and stamp

only those weights and measures, which are covered under the terms transaction and protection defined under the Act.

3. Further the enforcement officers may be directed not to insist for the verification of weights and measures used for internal use in the industries, if these weights and measures do not affect the quantity delivered to the consumers and are not used for any transaction or for protection.





Sir,

The undersigned is directed to refer to the above mentioned subject and to state that:

(i) It has come to the notice that there is no uniformity of test weights requirement for testing of weighing machines/ weighbridges. Most of the State enforcement officers require standard weights of 1/10th of machine capacity whereas few States requires 1/3rd of hine capacity.

As per the Model Enforcement Rules circulated to/ framed by the State Governments, it is provided that the user of weighing instrument shall keep at the site of capacity of the instrument or one tonne whichever is less.

Therefore, in the interest of industries, it is advised to direct field staff to ensure the compliance of the provisions of Rules.

- (ii) Under the Legal Metrology (Packaged Commodities) Rules, 2011 the secondary packing used for Transportation does not require any labelling as the package is not for package only. The enforcement officers may be directed accordingly.
- (iii) Under Rule 6(2) of the Legal Metrology (Packaged Commodities) Rules, 2011 it is mandatory to declare name, address and contact details of the person who can be section 2(m) of the Act as follows:

(m) "person" includes,(i) a Hindu undivided family,
(ii) every department or office,
(iii) every organisation established or constituted by Government,

(iv) every local authority within the territory of India, (v) a company. Ifmi and association of individuals, (vi) trust constituted under an Act, (vii) every co-operative society, constituted under an Act, (viii) every other society registered under the Societies Registration Act, 1860;

Therefore, the declaration of name of the company is sufficient compliance of provisions of rules.
